PROCEEDINGS OF THE PLATTE COUNTY BOARD OF SUPERVISORS

Columbus, Nebraska November 15, 2016 Tuesday, A.M.

Pursuant to adjournment the Platte County Board of Supervisors met in session beginning at 9:10 a.m. Honorable James Scow, Chairman, Diane C. Pinger, County Clerk. Roll Call and the following members present: Supervisors Martens, Micek, Olk, Pfeifer, Lloyd, Engdahl and Chairman Scow The Chairman informed the public of the posting of the open meeting laws. The Affidavits of Publication were presented. The meeting notice was published in the Columbus Telegram and the Humphrey Democrat on November 9, 2016. Motion, Supervisor Micek, seconded Supervisor Lloyd, to approve the agenda as presented, and vote was as follows: Voting Ayes: Supervisors Micek, Olk, Pfeifer, Lloyd, Engdahl, Martens and Chairman Scow Voting Nays: None Whereupon the Chairman declared the motion carried. Motion, Supervisor Micek, seconded Supervisor Lloyd, to approve the minutes for November 1, 2016, and vote was as follows: Voting Ayes: Supervisors Micek, Olk, Pfeifer, Lloyd, Engdahl, Martens and Chairman Scow Voting Nays: None Whereupon the Chairman declared the motion carried. Donald E. Workman, MAXIMUS explained the Indirect Cost Allocation plan and indirect rate computations for period of FY 2018 and discussed the contract renewal for 2016, 2017 and 2018. Motion, Supervisor Olk, seconded Supervisor Engdahl, to postpone the decision on the Maximus contract to December 13, 2016, and vote was as follows: Voting Ayes: Supervisors Olk, Pfeifer, Lloyd, Engdahl, Martens and Chairman Scow Voting Nays: Supervisor Micek Whereupon the Chairman declared the motion carried. Carl Hart Jr., County Attorney discussed salary recommendations for the three Deputy County Attorney's with the County Board. 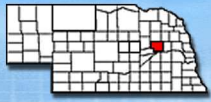
